02/19/8.1	Over the Counter (OTC) consultation The committee was advised of the plans to promote the use of OTC preparations. Doncaster plans Briefing packs for general practice, care homes and schools are being prepared. A media campaign will be started in March 2019. NHSD has prepared a list of items available OTC and these items may be added to the TLS for categorisation. The Optimise Rx system will also support this. The LPC asked if there will be system in place to refer patients into Primary Care if the OTC route is not appropriate. NHSD asked if a template slip could be developed and shared with NHSD prior to the distribution of the briefing packs. It was confirmed that the Minor Ailments system in Doncaster will remain as it is at this time. ICS plan NHSB advised the committee that the ICS media campaign will be to update the public on the results of the consultation and provide a reminder of the recommendation to purchase OTC preparations. 	reflect current treatment recommendations. RDaSHFT highlighted the national guidance from NICE and suggested this could be a source of reference until the local guidance was updated. Following discussion it was agreed that this guidance does not represent local decisions and as such would lead to confusion; the preferred option would be to ensure the local guidance is updated as soon as possible. NHSB advised the committee of resource issues and realistically thought this would be at least 2 months before completion.
