Traffic Light Status (TLS) additions and changes

TLS Integrated medicines Optimisation Committee (IMOC) List April 2024 Please Note: TLS status finalised at IMOC all items are classified as non-Formulary unless stated otherwise.

- ALERT There are now TWO TLS STATUS OF AZATHIOPRINE :
 - Azathioprine AMBER 1,2ab for 25mg and 50mg Tablets, in line with current shared care protocols.
 - Azathioprine GREY 3 for 75mg & 100mg strengths which should not be prescribed due to safety concerns.
- Antimalarials are classified as Grey 2 for Prophylaxis treatment of malaria for more information <u>click this link</u>

Eclipse Live Update

The Eclipse Live roll out is going well with 21 practices currently signed up and 18 have gone live. We have a 3 further practices waiting to go live. If you still have not signed up to Eclipse Live and would like to download a contract you can find it by <u>clicking this link</u>

There are currently training sessions ongoing for live practices and these are going well. If you have not yet gone live, we will be organising further training sessions in the coming weeks and will invite live practices via MS Teams.

Some of the items may not routinely have been picked up as significant by GPs so this has been helpful in highlighting anomalies. Very keen to continue using.'

New and updated Guidance Documents

Local **Ocular Lubricant Guidance** has been updated for the treatment of mild, moderate to severe and more severe dry eye conditions. For short-term conditions patients should be advised to purchase over the counter products(OTC) for long-term conditions. Top Tips for Prescribers -Did you Know?

1.Phenergan[®] 25mg tablets are more cost effective than the generic promethazine hydrochloride 25mg tablets. Open prescribing information can be <u>found here</u>

2. Luforbec[®] inhaler is more cost effective than Fostair[®] inhaler and is first line choice on the local formulary for asthma. Follow <u>this link</u> to the MPD.

3. Paracetamol and tramadol combination- Should not routinely be prescribed in primary care in line with national guidance. <u>Click here</u> for more information.

4. Prolonged-release Doxazosin costs SIX times more than doxazosin immediate release. Use doxazosin rather than Doxazosin prolonged release. For more information <u>click here</u>.

5.Oxycodone and naloxone combination product (Targinact®)- should not routinely be prescribed in primary care. Follow <u>this link</u> to the MPD

OptimiseRx Update April 2024

- In March 2024 the acceptance rate of optimise messages increased across Doncaster Place, with a total saving of £27,867 and a further £30,000 in cost avoidance.
- It is important to remember that Optimise Messages are not always about cost and also include some very important 'Best Practice' and 'Safety' messages.
- They are regularly added, removed and updated; For example, the recent MHRA Safety Update regarding Acenocoumarol/Warfarin and tramadol, concomitant use is not recommended. Optimise has presented the message below 22 times since being enabled in January 2024, where concomitant use could have occurred, avoiding the increased risk of bleeding highlighted in the alert.

New Pharmacy First materials aimed at GPs, Service case study : Optical referral for Hypertension Case-Finding Service pilot

Community pharmacies and optical practices in Humber and North Yorkshire are working together to identify patients suitable for the Hypertension Case-Finding Service in a pilot which has recently been commissioned for another year (until 31st March 2025).

Across the two areas, so far, 126 community pharmacies and 36 optical practices have participated in the pilot, where opticians can refer patients that have been identified with raised blood pressure to a community pharmacy for the Hypertension Case-Finding Service.

Shortage of salbutamol 2.5mg/2.5ml and 5mg/2.5ml nebuliser liquid unit dose vials

Salbutamol 2.5mg/2.5ml nebules will be in limited supply from mid-April until late June 2024.Salbutamol 5mg/2.5ml nebules will remain available, however, cannot support an increase in demand.

The microbiologists at DBTHFT have asked for a message to primary care in Doncaster and Bassetlaw that the antibiotic susceptibility reporting on ICE has been changed and is effective immediately. In particular the abbreviation "I", which used to mean "intermediate" in previous reports, now means "Susceptible, Increased exposure".
