Introduction

The purpose of the Place Medicines Optimisation Committee and its sub-functions is to bring together the senior pharmacy professionals and prescribers from each of the stakeholder organisations at Place to provide a forum to steer the implementation of the strategic plans from the South Yorkshire ICB Integrated Pharmacy & Medicines Optimisation (IPMO) board and commissioning decisions from South Yorkshire Integrated Medicines Optimisation Committee (IMOC), at Place.

This expert multidisciplinary group will work collaboratively to co-ordinate and agree the Place implementation of prescribing guidelines and commissioning arrangements agreed at South Yorkshire (system) level, to provide consistent and equitable access and pathways and to support the use of evidenced based, cost-effective, sustainable medicines safely within relevant care settings across SY ICS in order to improve outcomes for patients accessing healthcare in South Yorkshire.
